Chairman Ken Baker called the meeting to order at 3:00 p.m.

3. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION REGARDING:

Chairman Baker presented Roland Mower with a certificate recognizing Mower's time of service in Clinton. This is Mower's last meeting before he retires.

Trustee Meacham stated that he does not believe that an Executive Session is in order even though Mower's retirement will create a vacancy which will need to be filled. He requested the discussion of the Economic Development Director position in open session.

Chairman Baker agreed with Trustee Meacham's comments. No motion was made to enter into Executive Session. The Trustees discussed the future of the Economic Development Director position in open session.

Mayor Berrong provided historical information regarding how CEDA was started and the intentions of the Authority and director position. Mayor Berrong stated that we do face challenges and we need to be realistic with our goals moving forward.

Trustee Meacham stated that he would like to see the Authority define the role of the new director to be more specific for commercial, housing, retail, and identify what is the most important to the community for the next five years. He stated that he felt that we have to correlation between jobs, family/housing, and retail for economic growth.

Roland Mower, outgoing Economic Development Director reported on the highway project moving forward was great news for the Clinton. He stated that he sees the City of Clinton needing to focus on resolving the hospital issues, a study of the water production could be done to partner with other entities for the sale of water or to lease/se the R/O plant to decrease the cost of water and debt load on the City. He feels the cost of water inhibits growth. He stated that the Clinton Public Schools will be key in bringing growth and any improvements in that area are instrumental in recruiting families to the town. He encouraged the Authority to stay engaged at a state level and to support the businesses that are currently in our community.

Newly appointed Trustee Liz Johnson reiterated that a clear vision of what is needed for Clinton should be under consideration regarding housing, jobs, and community development.

Other comments were provided by citizens Dan Tharp and Patricia Kosta who are concerned about the future development of Clinton.
